The Directors present their report on Ardea Resources Limited (Ardea or the Company) and the entities it controlled at the end of and during the half-year ended 31 December 2025 ("financial period").

DIRECTORS

Mathew Longworth – BSc (Hons) MAusIMM

Non-Executive Chair Appointed 31 July 2020

Mathew Longworth is a geologist with over 39 years' experience across exploration, project evaluation/development, operations and corporate management. He previously held roles as Exploration Manager, COO, and CEO/Managing Director with Australian listed companies, and Mining Consultant with Xtract Mining consultants. In his senior corporate roles, Mathew led multidisciplinary project evaluation and development teams. Mr Longworth is a member of the Australasian Institute of Mining and Metallurgy.

Mr Longworth has excellent experience of the key Ardea exploration and development projects, being the Kalgoorlie Nickel Project (KNP). Mr Longworth joined Heron Resources in 2003 as Exploration Manager, rising to Managing Director from 2007 to 2011. Mr Longworth applied his intimate knowledge of the Eastern Goldfields geology to the KNP to collaborate with Vale Inco in their 2005 to 2009 KNP feasibility study.

He is currently Chairman of the unlisted Company Greenfields Exploration Pty Ltd, until recently Non-Executive Director at Asra Minerals Ltd, and Non-Executive Chairman of unlisted Northam Resources Limited. Mr Longworth has no other public company directorships.

This includes the successful optimisation of Murrin Murrin, Australia's largest and longest-running nickel laterite high pressure acid leach (HPAL) operation producing refined nickel-cobalt.

Andrew Penkethman is a resources sector executive and geologist with over 30 years' experience in the industry. His technical skills include project evaluation, exploration, discovery, resource development, feasibility study management, permitting, stake holder engagement and mine development across open pit and underground operations within Australia and overseas. Commodities experience includes battery minerals, base metals, gold and energy commodities over a range of geological settings.

Mr Penkethman's technical expertise is complimented with a strong corporate focus including investor relations, capital raising, strategic partner processes, joint venture management, and project acquisition and divestment. 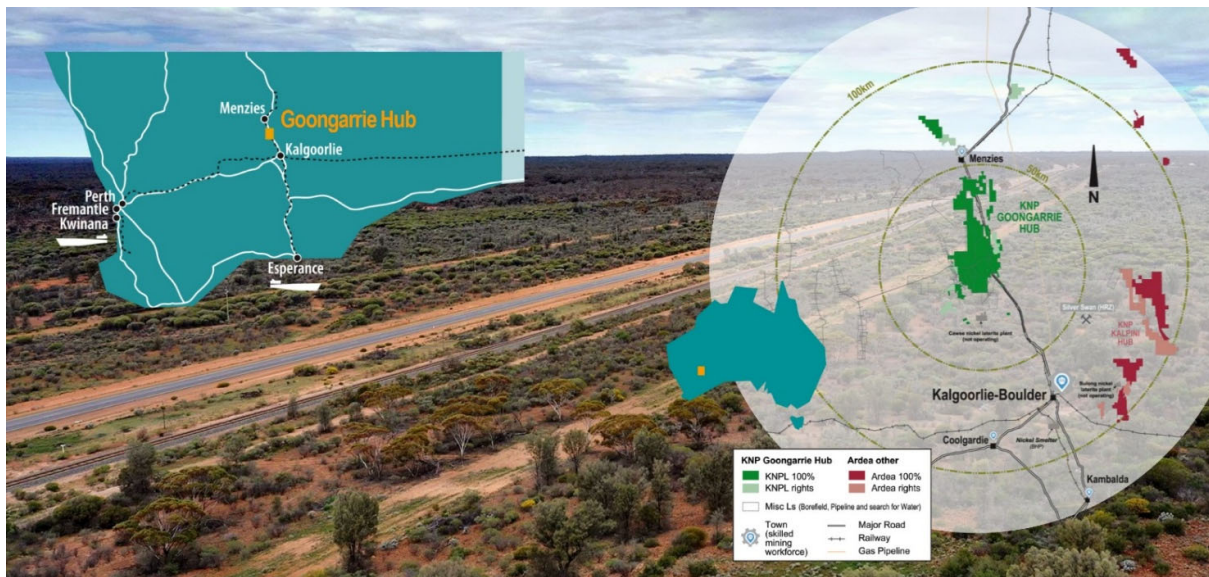
REVIEW OF OPERATIONS AND ACTIVITIES

The Consolidated Entity recorded an operating loss after income tax for the Financial Period ended 31 December 2025 of \$2,352,476 (2024 half-year loss of \$3,883,403). As of 31 December 2025, Ardea Resources Limited maintained a **strong financial position** with **\$11,637,038 in cash** and **no debt**, ensuring sufficient liquidity to support the continued advancement of the Kalgoorlie Nickel Project (KNP). In parallel, the Consortium, comprising Sumitomo Metal Mining Co., Ltd (SMM) and Mitsubishi Corporation (MC), has committed **A\$98.5 million** in funding for the KNP – Goongarrie Hub Definitive Feasibility Study (DFS), with **A\$25.6 million** remaining to be expended as of 31 December 2025.

Ardea is a Critical Minerals Company, focused on the development of its globally significant, nationally strategic, KNP. The KNP is comprised of a series of major undeveloped nickel-cobalt-scandium laterite deposits which total **854Mt at 0.71% Ni and 0.045% Co for 6.1Mt of contained nickel and 386kt of contained cobalt**. The **Goongarrie Hub**, within the KNP, hosts **584Mt at 0.69% nickel and 0.043% cobalt for 4Mt of contained nickel and 250kt of contained cobalt** (ASX release 30 June 2023). The Goongarrie Hub is part of KNPL Incorporated Joint Venture (ASX Release 30 August 2024).

The KNP global Mineral Resource Estimate (using a 0.5% Ni cut-off grade) is shown in Table 1 of Appendix 1.

All KNP projects are located within 150km of the City of Kalgoorlie-Boulder, Western Australia.

Key Events for the Half-Year Ended 31 December 2025

Kalgoorlie Nickel Project – Goongarrie Hub

Definitive Feasibility Study (DFS) Progress

DFS funding and joint venture earn-in milestone

On 4 July 2025, the Company announced that its Japanese strategic partners, Sumitomo Metal Mining Co., Ltd and Mitsubishi Corporation (the Consortium), earned a combined 17.5% equity interest in Kalgoorlie Nickel Pty Ltd (KNPL) following expenditure of 50% of the approved A\$98.5 million DFS budget. Achievement of this milestone reflected disciplined execution of DFS work programs and represented a key step in the Consortium's staged earn-in to the Project under the joint venture arrangements (ASX release 4 July 2025).

DFS advancement and workstream progression

Throughout the half-year, the DFS advanced materially across all major technical disciplines, including geology, metallurgy, mine planning, processing, infrastructure and approvals. With field-based drilling and metallurgical testwork largely completed in earlier periods, work during the half-year increasingly focused on interpretation, optimisation, integration of technical outcomes and progression toward final engineering and cost estimation (ASX release 8 December 2025; ASX release 30 January 2026).

DFS schedule and cost outlook update

On 8 September 2025, the Company provided the market with an update to the DFS schedule, advising that completion is forecast for the first half of calendar year 2026. The updated schedule reflected the cumulative effect of minor delays across multiple workstreams and the Company's focus on achieving optimised and well-informed technical and commercial outcomes rather than accelerating delivery at the expense of study quality. The Company also advised that ongoing engineering refinement, updated design assumptions and market-driven cost inputs were expected to result in an increase to the Project's estimated capital cost relative to earlier studies, with the final capital estimate to be determined as part of the completed DFS. This increase is being assessed in parallel with value engineering initiatives, design optimisation and funding strategy considerations as part of the DFS process (ASX release 8 September 2025).

Mineral Resource and mine planning

During the period, Mineral Resource interpretation and modelling were completed for key Goongarrie Hub deposits, enabling updated mine designs, mining schedules and Ore Reserve studies to progress. These activities represent a critical step in converting the Project's substantial mineral endowment into a mine plan capable of supporting robust economic assessment under the DFS (ASX release 30 January 2026).

Metallurgy and process engineering

DFS metallurgical testwork programs were finalised during the half-year, with results undergoing detailed interpretation and incorporation into the DFS process design. This work supported refinement of the processing flowsheet, recovery assumptions and operating parameters, forming a key input to capital and operating cost estimates and overall Project economics (ASX release 30 January 2026).

Infrastructure, hydrogeology and energy studies

Non-process infrastructure design advanced during the period, alongside borefield drilling, test pumping and hydrogeological modelling to confirm water supply assumptions. Supporting engineering studies also progressed to assess power supply, energy integration and infrastructure solutions appropriate for the Project's scale and location, all of which are integral components of the DFS cost and execution framework (ASX release 30 January 2026).

DFS report preparation

Drafting of DFS report chapters progressed during the half-year as technical workstreams transitioned from execution to consolidation. This included preparation of supporting documentation, technical appendices and internal reviews to ensure consistency, accuracy and alignment across disciplines in advance of DFS completion (ASX release 30 January 2026).

Approvals, ESG and Community

Heritage and environmental approvals

During the half-year, KNPL progressed heritage and environmental activities in support of the DFS, including completion of multiple Aboriginal heritage surveys and environmental baseline studies across the Goongarrie Hub and associated infrastructure corridors. These activities are intended to support future statutory approvals processes and reduce development risk through early engagement and data collection (ASX release 30 January 2026).

Major Project Status renewal

On 20 October 2025, the Company announced that Major Project Status for the Kalgoorlie Nickel Project – Goongarrie Hub was renewed by the Australian Federal Government for a further three-year term. Renewal of this status recognises the Project's strategic importance as a critical minerals development and facilitates continued whole-of-government coordination and support (ASX release 20 October 2025).

Community engagement

The Company and KNPL continued to engage with Traditional Owners and local communities during the period, including support for culturally significant events and community initiatives in the Eastern Goldfields. These activities form part of the Company's broader commitment to responsible project development and maintaining a strong social licence to operate (ASX release 30 January 2026).

Health and Safety

The Company and KNPL recorded zero Lost Time Injuries during the half-year. Safety performance remained a priority across all Project and field activities, supported by established systems, contractor oversight and ongoing monitoring of site and field operations (ASX release 30 January 2026).

Financial Position

At 31 December 2025, the Company reported cash on hand of \$11.6 million and no debt. The DFS continues to be fully funded by the Japanese Consortium up to the approved A\$98.5 million DFS budget, preserving the Company's balance sheet while the study is completed (ASX release 30 January 2026).



DFS Activities during the half year, included completion of the RC Infill drilling program, being used for Mineral Resource Estimate update. A diamond drilling program was also completed with geotechnical and geological logging.

WA Nickel Sulphide and Critical Minerals (100% Ardea)

Ardea controls an extensive and highly prospective tenement portfolio which covers over 3,500km² in the Eastern Goldfields world-class Critical Minerals province. Mineral discovery via exploration provides Ardea with the opportunity to add additional Company value.

These letters are indicative only and subject to further due diligence, approvals and the satisfaction of customary conditions. The Directors have determined that this event does not require adjustment to the financial statements for the half-year ended 31 December 2025, as no binding financing arrangements were in place at balance date.
